JUDGMENT

The petitioner has approached this Court impugning conditional orders passed in appeals as against assessment orders. The impugned assessment orders are produced as Exts.P1 and P1 (a). The conditional orders are produced as Exts.P3 and P3(a). The only prayer of the petitioner is that he may be given an instalment facility to pay the amount ordered in Exts.P3 and P3(a) in three instalments.
