Heard learned counsel for the petitioner and the learned Government Pleader. No notice is being issued to respondents 4 to 6 in view of the judgment being passed today.

2. Petitioner has filed this writ petition for police protection. Petitioner claims to be a registered charitable trust which is running educational institutions. Allegations have been made against respondents 4 to 6 alleging obstruction in running various education programmes by the petitioner. Reference is also made to an interim order dated 16/07/2015 in W.P.C.No.21496/2015 filed by the petitioner.

3. The learned Government Pleader, on instructions submits that, after receipt of the complaint from the parents of the students, petitioner as well as parents were called and a meeting was held in which parties agreed that the matter shall be sorted out. It is submitted by the learned Government Pleader

that, as on date, there is no obstruction or any interference. It is further submitted that the police station is very nearby and it shall be open for the petitioner to approach the police, if there is any interference.

Recording the submission of the learned Government Pleader, we close this writ petition.
