Heard learned counsel for the petitioner and the learned Government Pleader.

2. This writ petition is filed seeking police protection. Petitioner's case is that she was attacked by respondents 5 to 9, with regard to which, crime has been registered as Crime No.788/2015. Petitioner submits that still there are threats from the private respondents.

3. The learned Government Pleader, after obtaining instructions, submits that, on receipt of the complaint, crime was registered and private respondents were also arrested and remanded. Investigation is in progress. It is further submitted by the learned Government Pleader that police is keeping a vigil and as and when any complaint is received from the petitioner, the same shall be looked into.
