Petitioner seeks for a direction to the 2nd respondent to carry out an effective investigation expeditiously in Crime No.236/2015 of the Museum Police Station, Thiruvananthapuram. According to the petitioner, even though the CC TV footages from the legislative assembly were obtained by the 2nd respondent for the purpose of investigation, no effective further steps have been taken in the matter.

2. Heard learned counsel for the petitioner and learned Public Prosecutor.
