JUDGMENT

The issue involved in the writ petition is squarely covered in favour of the petitioner by the decision of the Hon'ble Supreme Court in **State of Kerala v. Sneha Cheriyan** [2013 (1) KLT 755 SC] and the decision of this Hon'ble Court in **Nair Service Society v. State of Kerala and others** [2014 (4) KLT 921]. Accordingly, the writ petition is allowed by directing the 1st respondent to approve the appointment of the petitioner as UPSA with effect from 04.06.2008 on regular scale of pay basis within a period of one month from the date of receipt of a copy of this judgment. The 1st respondent shall also take steps to disburse the consequential monetary benefits, flowing to the petitioner from the said approval within a period of one month thereafter. The petitioner shall produce a copy of the writ petition together with a copy of this judgment before the 1st respondent for further action.
