JUDGMENT

It is conceded that the building of the petitioner has been provisionally numbered pursuant to the interim order in this writ petition. The status quo shall continue till Appeal No. 226/2015 is finally disposed of by the Tribunal for Local Self Government Institutions.

2. The question whether the construction of the building is unauthorised or not is a matter to be considered in the appeal. The question of making the provisional numbering absolute will depend upon the outcome of the appeal by the Tribunal.
