JUDGMENT

The re-classification of the bank from a primary agricultural credit society to a non-agricultural credit society is impugned. The issue has become academic since the bank in question – Kulanada Service Co-operative Bank Limited – is not now functioning. It is reported that proceedings are afoot in liquidation in respect of the bank.

The writ petition is hence dismissed clarifying that the order impugned will not stand in the way of raking up the issue of classification if and when the bank is restarted.
