JUDGMENT

The 1st petitioner, who is the manager of an aided school and the petitioners 2 to 9, who are the teachers working in the said school, are aggrieved by the denial of approval to their appointments on regular scale of pay basis. It is the case of the petitioners that, while the appointments were approved by the 4th respondent, the same was done only on daily wage basis from the date of appointments till the end of the academic year and only thereafter on regular basis from the next academic year. Highlighting their grievance, they have preferred Exts.P2, P4, P6, P8, P10, P12, P14 and P16 revision petitions before the 1st respondent and the limited prayer in the writ petition is for a direction to the 1st respondent to consider and pass orders on the said revision petitions expeditiously, after hearing the petitioners.

2. I have heard the learned counsel appearing for the petitioners as also the learned Government Pleader appearing for the respondents.

On a consideration of the facts and circumstances of the case and also the submissions made across the bar, I dispose the writ

petition with a direction to the 1st respondent to consider and pass orders on Exts.P2 to P16 revision petitions, after hearing the petitioners, within a period of one month from the date of receipt of a copy of this judgment. The petitioners shall produce a copy of the writ petition together with a copy of this judgment before the 1st respondent for further action.
