JUDGMENT

If any amount is due to the petitioners, that shall be disbursed as expeditiously as possible, at any rate, within a period of six weeks from the date of taking a decision. The 4th respondent shall disburse the salary time to time as and when due without any delay. If there is delay, that shall be

communicated to the petitioners.

The writ petition is disposed of with the above directions.
