J U D G M E N T

The petitioner is seeking a direction to the respondent to consider Ext.P1 request for revision of own timings in respect of stage carriage bearing Reg.No.KL-07/AH-9890 covered by regular permit on the route between Manjeri and Karinkathoni. The petitioner alleges that the timings are fixed in such a manner that he is not in a position to operate and vacant timings have also arisen on the said route. According to him, if those timings are allotted to the petitioner's service, it would be beneficial to the petitioner as well as to the travelling public. Hence, this writ petition.
