JUDGMENT

The petitioner was before this Court challenging the transfer of the petitioner from Group Centre, Pallipuram to 170 Battalion, Bijapur, Chattisgarh evidenced by Ext.P10 movement order. Though the petitioner had many contentions against the transfer, the petitioner in the meanwhile had submitted an application for voluntary retirement, which was considered and allowed; permitting the petitioner to voluntarily retire on 01.10.2015. The petitioner had also been continuing in the Group Centre, Pallipuram on the basis of the interim order passed by this Court.

2. Today when the matter was taken up the learned CGC Smt.O.M.Shalina on instruction submits that the petitioner's name has been struck off from the rolls;

on voluntary retirement. Nothing survives in the writ petition. The petitioner would be deemed to have retired voluntarily, from Group Centre, Pallipuram.
