J U D G M E N T

Aggrieved by the denial of approval to their appointments as non-teaching staff, the petitioners have preferred Exts.P18, P19 and P20 revision petitions before the 1st respondent. The limited prayer in the writ petition is for a direction to the 1st respondent to consider and pass orders on Exts.P18, P19 and P20 revision petitions expeditiously after hearing the petitioners.

2. I have heard the learned counsel for the petitioners and the learned Government Pleader for the respondents.
