JUDGMENT

The matter can be given quiteous in the light of Ext.P16 order dated 20.08.2015 issued by the Transport (B) Department. The order enables the petitioner to apply for regular permit to run the stage carriage as Limited Stop Ordinary Service.

2. The petitioner is free to approach the Regional Transport Authority for the regular permit and the first respondent for temporary permit. The petitioner is also at liberty to seek release of the vehicle seized after satisfying Ext.P14 charge memo. The vehicle shall be released to the petitioner on his paying the compounding fee for which he is readily agreeable.

The Writ Petition is disposed of.
