JUDGMENT

The petitioner confines his relief to an early consideration of Ext.P7 representation submitted by him. The same pertains to the expression 'private service vehicle' as defined in Section 2 (33) of the Motor Vehicles Act, 1988. The petitioner seeks an early consideration of the representation in the circumstances.
