J U D G M E N T

The petitioner has filed Ext. P5 objection to the demand made under Ext. P4 and P4(a) communications. The petitioner contends that no orders have hitherto been passed after considering Ext. P5 objection. The petitioner has in the meanwhile been served with Exts. P6 and P10 bills pursuing the demand.

2. I direct the fourth respondent to consider Ext. P5 objection with notice to the petitioner within a period of one month. The coercive steps pursuant to Exts. P6 and P10 bills shall be put on hold in the meanwhile. The petitioner is free to raise additional grounds at the time of hearing.
