JUDGMENT

The employer-employee relationship between the fourth respondent and the petitioner is pending adjudication in the arbitration case. It will be inequitable therefore to permit the petitioner to do sweeping job in the fourth respondent bank pending arbitration case. I do not therefore propose to interfere with Ext. P10 interim order passed in the arbitration case pending.

2. I however direct the Co-operative Arbitration Court, Thiruvananthapuram to dispose of A.R.C. No. 34/2014 on its file expeditiously. Every endeavour shall be made to take the proceedings to a logical end within a period of four months from today.

The writ petition is disposed of.
