The petitioners have approached this Court seeking for police protection in the matter relating to conduct of a meeting of the Managing Committee of the Society. It is stated that the 6th respondent is the Authorised Officer to conduct the meeting and the petitioners apprehend that the meeting may not be conducted, as the situation is such that the 6th respondent will not be in a position to conduct the meeting properly, for which, necessary police protection is required.

2. Learned State Attorney on instructions would submit that sufficient police will be available, but the police cannot enter into the hall where meeting is being held.

Under such circumstances, we do not think that any direction as sought for can be granted. We take on record the
