J U D G M E N T

The petitioner, who was appointed as HSST - Physics (Junior) in the 5th respondent School, is aggrieved by the denial of approval to the said appointment. In this connection, he has preferred Ext.P5 revision petition before the 1st respondent, and the limited prayer of the petitioner in the writ petition is for a direction to the 1st respondent to consider and pass orders on Ext.P5 revision petition, expeditiously, after hearing him, within a stipulated time.
