JUDGMENT

The petitioner confines his relief to an early consideration of two applications filed for regularisation of unauthorised construction. The same are in respect of two buildings owned by the petitioner. The petitioner relies on Ext. P8 acknowledgment in proof of the e-filing of the applications for regularisation.

2. I direct the second respondent to consider the applications put in for regularisation evidenced by Ext. P8 acknowledgement within a period of two months. The petitioner shall be put on notice and heard in the exercise. The status quo shall be maintained till orders are passed on the applications for regularisation as directed above.
