JUDGMENT

P.N. Ravindran, J.

The petitioner, who has appeared for and passed the entrance examination conducted by the Commissioner for Entrance Examinations, Kerala for admission to Professional Degree Courses, 2015, has filed this writ petition praying for an order directing the respondents to take necessary steps to fill the merit seats available for the MBBS degree course in all Medical Colleges in the State of Kerala on the basis of the rank list published by the Commissioner for Entrance Examinations. The petitioner has also prayed for various other reliefs including an order directing the State of Kerala, the Director of Medical Education and the Commissioner for Entrance Examinations to take steps to compel the managements of the self financing medical colleges in the State of Kerala to enter into seat sharing agreements with the Government.

2. When the writ petition came up for hearing today, Shri Philip Mathew, learned counsel appearing for the petitioner submitted that after this writ petition was filed, the petitioner got admission for the

MBBS degree course in the Kolencherry Medical College and that she has no subsisting grievance now.

In such circumstances, this writ petition is closed as infructuous leaving open the contentions raised by the petitioner.
