JUDGMENT

The petitioner asserts that there is a discrepancy in Ext.P3 birth certificate as regards his date of birth. The date of birth is wrongly shown as 22.09.1980 instead of 12.09.1980. The petitioner relies on his SSLC Book, Passport, Certificate of Baptism and marriage certificate to establish that his date of birth is 12.09.1980.

2. The remedy of the petitioner is to have Ext.P3 birth certificate corrected. The petitioner is free to move the first respondent with an appropriate application in this regard. Any application filed within two weeks from today shall be dealt with within four weeks therefrom. The petitioner shall produce a copy of the writ petition along with the judgment with the first respondent for compliance.

The Writ Petition is disposed of.
