JUDGMENT

The petitioners were temporarily appointed as Anganwadi Workers in various Anganwadi Centres under the ICDS Project, Panamaram, Wayanad District. They are ranked 1, 2 and 4 in Exhibit P1 seniority list and claim appointment in accordance with their ranks in that list. An Interlocutory Application [I.A.No.15601 of 2015] has also been filed, wherein it is pointed out that there exists a vacancy in Centre No.38 [Malankara Anganwadi] under the 4th respondent. The learned Government Pleader also, on instruction, submits that there is in existence such a vacancy from 01.11.2015 and the 1st petitioner would be considered to the said post and granted appointment in the light of Exhibit P5 judgment. The petitioners 2 and 3 also would be granted appointment in accordance with their rank, as and when vacancy arises.

The writ petition would stand disposed of as above. No costs.
