JUDGMENT

The petitioner has approached this Court on account of refusal to effect mutation in respect of his property covered by Ext.P6. As seen from Ext.P8, this property is included as Laksham Veedu Scheme and this has been assigned to the petitioner in violation of the Scheme.

This Court is of the view that the transfer of registry is being effected for fiscal purposes, mutation shall be effected in favour of the petitioner without prejudice to the official respondents to proceed against the property if it was assigned in violation of the Laksham Veedu Scheme. Needful shall be done within two weeks from the date of receipt of a copy of this judgment.
