JUDGMENT

The parents seek correction in the birth certificate of their son. The name of the son is written as 'Vivek Subrahmanian M.A.' instead of 'Vivek Subramanian M.A.'. The name of the father is shown as 'Anantharaman' instead of 'Anantharaman M.S.'. The name of the mother is written as 'Rethy Anantharaman' instead of 'Rathi Anantharaman'.

2. The corrections are inconsequential. The mistake occurred while translating the name from Malayalam to English. No prejudice would be caused to the respondents by the correction as sought. Ext.P11 notice declining correction is quashed. The municipality is directed to issue the corrected birth certificate immediately. The same shall be done within a period of two weeks.

The Writ Petition is disposed of.
