JUDGMENT

The petitioner seeks disbursement of arrears of revised pay for the period from 1.03.1997 to 31.10.1999 on account of the pay revision effected in the year 1997. The petitioner also seek disbursement of revised pension in the pay scale of the years 2006 and 2011 with arrears thereon from the period from 01.04.2009 and 01.02.2013.
