A total non application of mind is well evident from Exts.P5 and P6 orders impugned. All the parties agreed that the matter shall be reconsidered by the third respondent in a proper perspective. A fresh site inspection shall be conducted with notice to all the parties and orders passed anew within three months. The petitioner as well as respondents 4 to 6 are free to make available sketches suggesting the route along which the electricity supply line has to be drawn. Resultantly Exts.P5 and P6 orders are quashed for this limited purpose.
