JUDGMENT

The petitioner claims to be the owner and in absolute possession and enjoyment of two plots of property in Re-survey No.18/1, 18/5 and 18/6 in Vellathooval Village. The petitioner claims title to his property by the proceedings in L.A. Case No.7/95 and L.A. 5/95.

The petitioner submits that after the resurvey, there were certain mistakes in Basic Tax Register and Thandapper Register of the properties. It is submitted that instead of 'Purayidam', it is recorded as 'Tharisu'. The petitioner approached the Special Tahsildar to correct the records. It is on account of non consideration of petitioner's request, he has approached this Court.

This Court is of the view that the petitioner's request shall be considered by the District Collector. This shall be done within a period of three months. The District Collector is suo motu impleaded as additional third respondent after issuing notice to the petitioner.

The writ petition is disposed of as above.
