The petitioner is the driver in the KSRTC. He has filed Ext.P1 complaint before the Managing Director of the KSRTC, alleging that some spare part items and materials of the KSRTC from its workshop at the Aluva Depot were stolen by one Prasanna Kumar, who is a mechanic.

It seems that it is for the Managing Director of the KSRTC to take action in the matter. The Police have nothing to do with the matter. In case of any complaint of corruptions in the KSRTC, of course, the petitioner can approach the Vigilance Court with a complaint. Leaving open such remedies to the petitioner, this Writ Petition is closed.
