Shaffique, J.

Petitioners have approached this Court alleging threat and attack by respondents 4 to 7 and their men. The 4th respondent is the son of petitioners 1 and 2 and the allegation is that 4th respondent along with respondents 5 to 7 are unnecessarily threatening and creating law and order situation against the petitioners. Third petitioner is also the son of petitioners 1 and 2.

2. Learned Government Pleader on instructions would submit that the issues relating to family disputes cannot be gone into by the police. This writ petition was pending since 2013 and so far, no untoward incident had been reported. However, we observe that if there is any offence committed or attempt to commit offence, on the complaint of the petitioners, police shall
