'Dhanajna' became 'Dhanajna Devidas' after marriage. The same was however erroneously entered as 'Dhanatanai' in the municipal records. The name was changed as 'Dhanajna.E.' on the request of the father of the petitioner. There is no bar for further correction at the instance of the petitioner. The correct name is 'Dhanajna Devidas' which should be entered. The power of the Registrar of Births cannot be curtailed by any Government Order.

2. The second respondent shall carry out the correction on motion made by the petitioner. The same shall be done within a period of one month after its preferment.
