Heard learned counsel for the petitioner and the learned Government Pleader. No notice is being issued to respondents 3 to 5 in view of the judgment being passed today.

2. By this writ petition, the petitioner has prayed for a direction to provide police protection to convene the general body meeting at Manathala Nagayakshi Temple, Chavakkad, Thrissur District proposed to be held on 13/09/2015. Petitioner's case is that a registered society is managing the affairs of the temple and the present administrative committee members are not permitting to hold the general body meeting. It is submitted that the meeting was scheduled on 06/09/2015, but due to lack of quorum it could not be held and is postponed to 13/09/2015.

3. The learned Government Pleader, after obtaining instructions, submits that police presence was ensured on 06/09/2015 and shall be ensured on 13/09/2015 at the temple premises. Police authorities are there only to maintain law and

order. With regard to the affairs of the meeting, police cannot intervene.

In the above view of the matter, we dispose of the writ petition recording the statement of the learned Government Pleader that police presence shall be at the temple premises on 13/09/2015 to ensure that law and order is maintained.
