J U D G M E N T

The petitioner applied for duplicate patta of patta No.84/74. The petitioner approached this Court on account of delay in issuing duplicate patta.

2. The learned Government Pleader on instructions submits that the files relating to patta are missing and therefore it can be issued only after tracing out the missing files.

3. This Court is of the view that effective measures shall be taken to trace out the file and issue duplicate patta within two months from the date of receipt of the copy of the judgment. If it cannot be traced out, certificate shall be issued to evidence that such purchase certificate has been issued from the land tribunal after a period of two months.

The writ petition is disposed of, as above.
