J U D G M E N T

The petitioner approached the District Collector by way of Ext.P2 complaint. According to the petitioner, certain persons are attempting to encroach upon the Government land.

This Court is of the view that the second respondent shall conduct enquiry and find out whether there is encroachment. If an attempt of encroachment is made in the Government land or Government land has been encroached, necessarily appropriate action shall be taken in accordance with law to desist or evict encroachers. Needful shall be done after hearing the petitioner and others within a period of two months of date of receipt of a copy of this judgment.

This writ petition is disposed of as above.
