JUDGMENT

Petitioner was a clerk under the Executive Director, Centre for Water Resources Development and Management (CWRDM), Kunnamangalam, Kozhikode, the 2nd respondent herein. He retired from service on 30.09.2014. The petitioner, while he was in service, approached the 2nd respondent pointing out the anomaly in fixing pay based on the 9th pay revision. The petitioner's claim is that he is entitled to the scale of pay of ₹15380-25900. The petitioner made Exts.P4 and P5 representations before the 1st respondent.

2. The only request made by the petitioner before this Court is early disposal of Exts.P4 and P5 by the 1st respondent. In the facts and circumstances, there shall be a direction to the 1st respondent to consider and pass appropriate orders on Exts.P4 and P5, in accordance with law, after affording an opportunity of hearing to the petitioner within a period of six weeks. from the date of receipt of a copy of this judgment.

The writ petition is disposed of. No costs.
