J U D G M E N T

The petitioner appears to have approached the Tahsildar for measuring and demarcating his property. It is also seen from Ext.P5 that the Assistant Executive Engineer, PWD (Road) Sub Division also requested the Tahsildar to demarcate the road Puramboke. Petitioner submits that the proceedings based on Ext.P5 are yet to be concluded.

2. This Court is of the view that considering the nature of the prayer and in the light of Ext.P5, appropriate decision shall be taken by the second respondent to finalise the proceedings based on Ext.P5. Needful shall be done within a period of two months from the date of receipt of a copy of this judgment, after notice to the petitioner as well as PWD authorities.
