This writ petition is filed seeking for a direction to respondents 1 to 3 to render sufficient and adequate protection to the petitioner to conduct the classes in Nirmala College, Muvattupuzha. It is alleged that respondents 4 to 9 and their men are creating obstruction in the functioning of the College.

2. Learned Additional Advocate General submits that based on the complaint given by the petitioner, adequate steps have already been taken by the police to maintain law and order and is keeping a constant vigil on the activities of respondents 4 to 9. As and when necessary, on the request of the petitioner, the police shall provide necessary protection.
