JUDGMENT

The State Transport Appellate Tribunal has by an interim order granted temporary permit to the applicant. It appears that the permit was also issued without settlement of timings. The parties are more concerned with the time slot to be allotted.

2. The applicant (A.N. Vasanthi) has filed an affidavit dated 30.09.2015. She has undertaken to stop the service with effect from 01.10.2015. She would resume operation only after settlement of timings.

3. I therefore direct the Secretary of the Regional Transport Authority, Thrissur to convene a timing conference. The same shall be done with all the operators in the route. The exercise shall be completed within a period
