The petitioner, a candidate appearing for All India/Pre-Medical/Pre-dental Entrance Test, 2015, has approached this Court seeking allotment.

2. It is to be noted that counselling for admission was over on 11.9.2015 as per the orders of the Honourable Supreme Court and there is no further counselling. It is also to be noted that the entire balance seats have been surrendered to the State. The learned Standing Counsel for the Medical Counselling Committee placed before me a public notice issued surrendering the seats to the State.
