Shaffique, J

Petitioners have approached this Court seeking police protection. It is stated that the 4th respondent has brutally manhandled the 1st petitioner and though complaints have been filed before the police, no action has been taken in the matter.

2. The learned Government Pleader, on instructions, would submit that Ext.P4 complaint had been enquired into by the police, 4th respondent was arrested and later enlarged on bail on 22/08/2015. Thereafter, no untoward incident has been reported.

3. Having regard to the aforesaid factual situation, we are of the view that if there is any further offence or attempt to commit offence, it is always open for the petitioners to file necessary complaint before the police who shall look into the matter and take appropriate action, in accordance with law.

With the above observation, this writ petition is closed.
