Heard learned counsel for the petitioner and the learned counsel appearing for respondents 2 and 3.

2. This writ petition has been filed seeking to quash Ext.P5 notification issued by the Delimitation Commission by which draft proposal for fixing the boundary for dividing constituencies was notified.

3. Learned counsel for the 2nd respondent has pointed out that the revised schedule for delimitation has been issued on 25/09/2014 whereby, for District Panchayat, the date for filing objection has been extended upto 29/09/2015. In view of the revised schedule which give ample opportunity to the petitioner to file objection, we see no reason to entertain this public interest litigation.
