Heard the learned counsel for the petitioner and the learned State Attorney.

2. Petitioner has filed this writ petition alleging police harassment. Petitioner's case is that a case was registered against him being Crime No.1763/2014, in which crime, he was exonerated. It is submitted that now the 3rd respondent has directed the petitioner to appear before the 4th respondent on 22/9/2015. He submits that petitioner having been exonerated, calling the petitioner is nothing but police harassment.

3. Learned State Attorney after obtaining instructions submits that after the petitioner having been exonerated, *de facto* complainant has filed a writ petition before this Court and under the direction of this Court, respondents 3 and 4 are further investigating the matter and in that connection, petitioner has
