J U D G M E N T

No doubt the plea of regularisation in service put in by the petitioner was turned down pursuant to Ext.P11 judgment in W.P.(C) NO.22287 of 2012. But that does not debar the respondents from considering the claim of the petitioner anew in the light of Ext.P5 duty details furnished. Ext.P13 representation filed by the petitioner is pending consideration which deserves to be dealt with in accordance with the decision of this Court in Suresh Kumar v. State of Kerala [2013 (2) KLT 258].

2. I direct the first respondent to consider Ext.P13 representation with notice to the petitioner within a period of two months.
