Heard learned counsel for the petitioners and the learned Government Pleader.

2. This writ petition is filed alleging police harassment. Petitioners' case is that petitioners 1 and 2 are husband and wife and the 3rd petitioner is their son. It is submitted that there was strained relationship between the 3rd petitioner and his wife Ditty. It is submitted that petitioners are being called by the police authorities to appear which amounts to police harassment.

3. The learned Government Pleader, on instructions, would submit that in connection with a complaint submitted by the wife of the 3rd petitioner, 3rd petitioner was called. But he did not appear and crime No.1134/2015 has been registered against the 3rd petitioner.

In view of the above statement, we are of the view that the present is not a case of any police harassment. Hence this writ petition is closed.
