JUDGMENT

The petitioner has undertaken certain work on behalf of the National Games Authority. The petitioner has approached this Court for releasing the amount due to him.

2. It is admitted by the learned Standing Counsel for the first respondent that they have a liability to the petitioner. It is submitted that it is on account of delay in obtaining the amount from the second respondent, they could not effect the payment.
