All that the petitioner prays is for an early consideration of Exts. P1 to P5 petitions filed invoking Kerala Local Authorities (Prohibition of Defection) Act, 1999. The petitioner contends that orders have to be passed before the ensuing election to the local bodies since it has an effect on the eligibility to contest again.

2. Every endeavour shall be made by the first respondent to pass final orders on Exts. P1 to P5 petitions as expeditiously as possible.

The writ petition is disposed of.
