J U D G M E N T

The petitioners in the above writ petition are students, who had qualified the B.A graduate degree with double main subjects and who got admission in the B.ed course. The petitioners 1, 3, 4 and 5 passed B.A degree examination with Malayalam and Sociology as the double main subject from colleges affiliated to the Calicut University itself. The petitioners 2 and 6 had passed B.A degree examination with Arabic and History as the main subjects. However, it is not clear from the averments in the writ petition as to the subject in which they got admitted in the B.Ed. course.

2. The issue is covered by a judgment of this Court in W.P.(C)No.29540 of 2008 and connected cases. If the B.Ed is also one of the main subjects, then admission

has to be regularised going by the aforesaid judgment. However, if it is not in one of the main subjects but in any other subject, then the question of equivalency would have to be considered.

The writ petition is disposed of.
