JUDGMENT

1. Petitioner approached the Central Board of Secondary Education for correcting his father's name in the records. Mother's name has been corrected. But father's name has not been corrected. Petitioner refers to Gazette Notification showing the correct name of his father.
2. In that view of the matter, this writ petition is disposed of by setting aside the impugned order and directing the 3rd respondent to correct the father's name of the petitioner in the school records in the light of the Gazette Notification. The 3rd respondent is directed to forward the same to the Central Board of Secondary Education, without any delay. The CBSE shall take a decision in the matter, within a period of three months.
