The petitioner has approached this Court for the issuance of temporary permit for the stage carriage vehicle Nos.KL-5/G 8602 or KL-5/J 2322 in the vacant timing of stage carriage No.KL-5/P 5539 on the route Kottayam-Changanacherry.

If vacancy of stage carriage bearing registration No.KL-5/P 5539 is still in existence and no other person, having better claim has applied for a temporary permit to operate a stage carriage in that vacancy, there will be a direction to the 1st respondent to issue a temporary permit of four months duration within one week from the date of production of a copy of this judgment by passing appropriate orders on Ext.P1.
