Petitioner is arraigned as the 8th accused in Crime No.1281/2011 of Neyyattinkara Police Station, presently pending as Crime No.1020/CR/2011 CBCID, Thiruvananthapuram, for the offences punishable under Sections 489B and 489C IPC.
