J U D G M E N T

The petitioner is now working as HSA(Natural Science). Prior to the appointment as HSA, the petitioner was appointed as UPSA, which post was approved. The petitioner was promoted as HSA on 01.06.2011. The petitioner contends that the said promotion was not approved. The Manager of the school filed Ext.P13 appeal, in which 2nd respondent rejected the claim of the petitioner by Ext.P15. Against which petitioner filed Ext.P16 revision before the 1st respondent. Ext.P16 revision is dated 19.09.2015. The petitioner seeks expeditious consideration of the same.

2. In such circumstances, the 1st respondent shall consider and pass orders on Ext.P16, after affording the revision petitioner an opportunity of hearing, within a period of six months from the date of receipt of a certified copy of this judgment. It is made clear that this Court has not made any observation as to the merits of the case.
